On December 1, 2014, the Company held its 2014 Annual Meeting of Shareholders (the "Annual Meeting"). A total of 21,105,174 shares of the Company's common stock, par value \$0.002 per share, were entitled to vote as of the close of business on October 17, 2014, the record date for the Annual Meeting. The holders of 15,366,176 shares of common stock, a majority, were present in person or represented by proxy at the Annual Meeting, at which the shareholders were asked to vote on two proposals. The proposals are described in detail in the Company's definitive proxy materials which were filed with the Securities and Exchange Commission and first made available to shareholders on or about October 28, 2014. Set forth below is the matters acted upon by the Company's shareholders at the Annual Meeting, and the final voting results of each such proposal.

Proposal No. 1 – To elect three Class II directors for a three year term to serve until the 2017 Annual Meeting of Stockholders

The Company's shareholders voted for the election of the three Class II directors to serve until the 2017 Annual Meeting of Stockholders. The final voting results were as follows:
