- (1) On June 2, 2017, Mr. Hovde, the reporting person, sold 60 shares of the common stock of ePlus Inc (the "Shares") at prices ranging from \$79.50 to \$79.65.

- (3) Mr. Hovde is the managing member of Hovde Capital, Ltd., the general partner to Financial Institution Partners III, L.P. ("FIP III"). On June 2, 2017, FIP III sold 5,000 shares of the common stock of ePlus Inc (the "Shares") at prices ranging from \$79.50 to \$79.65.
- (4) Mr. Hovde is the managing member of Hovde Capital, Ltd., the general partner to FIP III, which, after the transaction reported on this line, owns 25,198 Shares. Mr. Hovde is a trustee of The Eric D. and Steven D. Hovde Foundation, which owns 17,500 Shares.
