Excess Benefits and Deferred Compensation Plan (the "Compensation Plan Trust") (1) are subject to automatic reinvestment of dividends pursuant to the Issuer's Dividend Reinvestment Plan. On January 20, 2006, dividends on these shares were paid and automatically reinvested in additional Class A Common Stock for the benefit of the Reporting Person by the Compensation Plan Trust in the amount of 203,4736 shares.
