Gipson ("Gipson") holds discretionary investment authority. Gipson owns \$4,000,000 Canargo Subordinated Convertible Notes due 9/1/09 which are convertible into CNR common shares at \$1.37/share. Gipson also owns 4,000,000 Canargo Warrants which are exercisable at \$1.37/share and expire 3/3/08. Shares owned under the assumed conversion of the notes and exercise of the warrants are reported under sole voting and sole dispositive authority.
