Item 9. Regulation FD Disclosure.

On June 15, 2004, Regal Entertainment Group (the "Company") paid a quarterly dividend in the amount of \$0.18 per share to the holders of record on June 10, 2004 of the Company's Class A and Class B common stock. In connection with the payment of the quarterly dividend, the Company was required to make an adjustment to the conversion price of the 3³/₄% Convertible Senior Notes due May 15, 2008 (the "Notes") pursuant to the Indenture, dated as of May 28, 2003, under which the Notes were issued. After adjustment for the quarterly dividend, effective June 16, 2004, the conversion price of the Notes is \$16.0176 per share.
