- (1) A total of 50,000 of the options were granted pursuant to the issuer's stock option plan, which vested as to 10,000 shares on September 15, 2002, the date of the execution of the stock option agreement reflecting the grant, and vested as to an additional 10,000 shares on September 15 of 2003, 2004, 2005 and December 30, 2005. The revised total of 6,250 options reflects the issuer's 1-for-8 reverse split effective January 1, 2010.
- (2) The options were originally issued in consideration of the reporting person's services to the issuer and without payment of cash consideration, under the issuer's stock option plan.
