- (1) The Board of Directors pursuant to a special meeting held of July 14, 2009 approved the cancellation of certain stock options and the re-issuance of new stock options. Subsequently, the Board of Directors pursuant to a special meeting held on July 31, 2009 approved the grant of the specific 250,000 stock options exercisable at \$0.50 per share (which were increased to 500,000 stock options in accordance with the forward stock split of 2:1 effective August 3, 2009).
