Each RSU represents the right to receive, without payment to the issuer, one newly-issued, fully paid and non-assessable common share of the issuer, subject to the terms and conditions of the RSU Plan and the grant certificate evidencing each grant. In the discretion of the Compensation Committee, upon vesting the value of the RSU grant alternatively may be paid in cash, or partly in cash and partly in common shares.
- (2) These RSUs are held by QVT Fund L.P., which also owns other shares of the issuer. The reporting person is a managing member of: (a) QVT Associates GP LLC (the general partner of QVT Fund L.P.) and (b) QVT Financial GP LLC, the general partner of QVT Financial LP (the investment manager of QVT Fund L.P.). The reporting person disclaims beneficial ownership of these RSUs as well as any and all other shares of the issuer held by QVT Fund L.P.
