The Offer, which was scheduled to expire at 5:00 p.m., Eastern time, on Friday, July 10, 2009, has been extended until 5:00 p.m., Eastern time, Friday, August 7, 2009, unless further extended. All other terms and conditions of the Offer remain unchanged. CF also announced that on July 6, 2009, it filed a certification with the United States Federal Trade Commission (FTC) that CF has substantially complied with the FTC s request for additional information in connection with the Offer.
