INFORMATION REQUIRED IN REGISTRATION STATEMENT

Item 1. Description of Registrant s Securities to be Registered

On March 16, 2015, the Board of Directors of The Macerich Company, a Maryland corporation (the <u>Company</u>), authorized a dividend of one preferred share purchase right (a <u>Right</u>) payable on March 30, 2015, for each outstanding share of common stock, par value \$0.01 per share, outstanding on March 30, 2015 to the stockholders of record at the close of business on that date. Each Right entitles the registered holder to purchase from the Company one one-thousandth of a share of Series E Preferred Stock, par value \$0.01 per share (the <u>Preferred Shares</u>), of the Company, at a price of \$275.00 per one one-thousandth of a Preferred Share represented by a Right, subject to adjustments. The description and terms of the Rights are set forth in a Rights Agreement (the <u>Rights Agreement</u>), dated effective March 17, 2015, between the Company and Computershare Trust Company, N.A. as Rights Agent.

The Rights Agreement (which includes the Form of Articles Supplementary for Series E Preferred Stock as Exhibit A, the Form of Rights Certificate as Exhibit B, and the Summary of Rights as Exhibit C) is attached hereto as an exhibit and is incorporated herein by reference. The description of the Rights is incorporated herein by reference to the description set forth under Entry into a Material Definitive Agreement in the Company s Current Report on Form 8-K, filed with the Securities and Exchange Commission on March 18, 2015 and is qualified in its entirety by reference to the Rights Agreement and such exhibits thereto.
