### **Joint DuPont and Dow Integration Planning Team Meets in Wilmington**

Leaders from Dow traveled to Wilmington last week to launch the newly formed Integration Planning Teams, one composed of DuPont executives and another of Dow executives. Using their expertise and experience, they rolled up their sleeves to start working out the details of what is one of the largest proposed corporate mergers in history.

Their task is to make all planning aspects of the transition as smooth as possible. From fulfilling all of the regulatory requirements to capturing the \$3 billion in synergies between Dow and DuPont, the teams will leave no detail to chance.

DuPont CFO Nick Fanandakis kicked off the meeting, laying out the structure and processes for the nearly 60 leaders who are driving this work. Under the guidance of an Executive Steering Team sponsored jointly by DuPont Chair & CEO Ed Breen and Dow President, Chairman and CEO Andrew Liveris three core work streams were defined:

- Close and Stand Up the Merged Company
- Identify and Capture Synergies
- Stand Up Three Independent Operating Companies (Agriculture Co., Materials Co., and Specialty Products Co.)

It was energizing for everyone to meet face to face and begin the important work of integration planning, said Stacy Fox, SVP and General Counsel, and DuPont lead for the Close and Stand Up MergeCo work stream. The possibilities created by Dow and DuPont combining, and the enormous opportunities that the three proposed businesses offer, really start to come to life the more the teams get to know each other.
