- (2) by taking the higher of the average closing price of the period from December 12-17, 2008 and the period from December 19-24, 2008. The final price to determine the number of shares was established on December 24, 2008.
- (3) Award made pursuant to the Carnival plc 2005 Employee Share Plan.
