- (1) Represents Special Incentive Stock Ownership Premiums (SISOPs) (phantom stock) awarded pursuant to the PG&E Corporation Executive Stock Ownership Program. SISOPs vest three years after the date of grant subject to accelerated vesting upon certain events. Unvested SISOPs are subject to forfeiture if certain stock ownership targets are not met. Vested SISOPs are automatically payable in an equal number of shares following termination of employment.
- (2) Includes 54.08 SISOPs awarded pursuant to the PG&E Corporation Executive Stock Ownership Program, and reflects the acquisition of 0.24 SISOPs on April 15, 2008, 0.25 SISOPs on July 15, 2008, and 0.32 SISOPs on October 15, 2008 upon the conversion of dividend equivalents received on those dates.

- (3) Represents the approximate number of shares of PG&E Corporation common stock held for the reporting person in the PG&E Corporation Stock Fund of the PG&E Corporation Retirement Savings Plan (RSP). That fund holds units consisting of PG&E Corporation common stock and a small short-term investments component. The number of shares is computed by dividing the value of the units by the daily closing price. Dividends are automatically invested in additional units at the election of the participant. These holdings have been trued up to conform to the RSP balance at January 2, 2009 and reflect the acquisition of approximately 1.83 shares on April 15, 2008, 2.54 shares on July 15, 2008, and 3.26 shares on October 15, 2008 due to dividend reinvestment.
