(1) Restricted shares granted under the PG&E Corporation 2006 Long-Term Incentive Plan (LTIP).

Restricted Stock Units (RSUs) granted under the PG&E Corporation 2006 LTIP. RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis upon a director's death, disability, retirement, or a change in control, as defined in the PG&E Corporation 2006 LTIP.

(3) This total includes 1088.25 units of phantom stock granted under the PG&E Corporation Non-Employee Director Stock Incentive Plan (SIP), and reflects the acquisition of 11.59 units of phantom stock on 4/15/09, 11.69 units of phantom stock on 7/15/09, 10.61 units of phantom stock on 10/15/09, and 10.06 units of phantom stock on 1/15/10, pursuant to a dividend reinvestment feature of the SIP. This total also includes 5,399.17 RSUs granted under the LTIP, and reflects the acquisition of 46.27 RSUs on 4/15/09, 46.69 RSUs on 7/15/09, 42.36 RSUs on 10/15/09, and 40.17 RSUs on 1/15/10, pursuant to a dividend reinvestment feature of the LTIP. The phantom stock units and the RSUs are automatically payable in shares of PG&E Corporation common stock only.
