Phantom stock units acquired pursuant to a deferred compensation agreement between reporting person and Company and/or increases to the Director's phantom stock credits under the Deferred Compensation Plan for nonemployee Directors due to deemed reinvestments of hypothetical dividends thereunder. Payment of the number of shares credited to the account occurs upon the Director's departure from the Board. Filer incorrectly reported on July 5, 2011 the acquisition of 192 stock units, however the correct number of stock units for this transaction is 208, and 1 stock unit resulting from aggregating fractional stock units are also included in this amended filing.
