That fund holds units consisting of PG&E Corporation common stock and a small short-term investments component. These holdings have been trued up to conform to the RSP balance as of 3/1/12, and reflect the acquisition of approximately 2.11 shares on 1/17/12 due to dividend reinvestment.
