## Explanation of Responses:

- (1) Based on Company performance during the 2012-2014 period, approximately 121.8% of the performance units vested (as previously disclosed, the reporting person had the opportunity to earn up to 200% of the number originally reported).
- (2) Shares were withheld to cover tax withholding upon the vesting of performance units.
- (3) This information is based on a plan statement dated December 31, 2014.

- (5) Based on Company performance during fiscal 2014, approximately 133.3% of the restricted stock units originally granted were earned (as previously disclosed, the reporting person had the opportunity to earn up to 200% of the number of units originally reported). The target number of units that may be earned is reported above; the maximum amount is 200% of the number reported.
- (8) Original option grant vests in three annual installments beginning on the date listed in the "Date Exercisable" column.
- (9) The transaction was an option grant. Accordingly, the reporting person did not pay a price to obtain the option.
