- (1) Restricted Stock and Option were granted on March 31, 2006. Restricted Stock and Option were approved for grant, subject to certain conditions which were met on March 31, 2006, by the Board of Directors of the Issuer on February 24, 2006. The Option has an exercise price equal to the closing price of the Issuer's Common Stock on February 24, 2006, which was \$20.34. The closing price of the Issuer's Common Stock on March 31, 2006 was \$19.27. The vesting commencement for the Restricted Stock and the Option is retroactive to February 24, 2006. The Option vests in four equal annual installments commencing one year after that date. The Restricted Stock vests entirely on the fourth anniversary of February 24, 2006, subject to potential acceleration.
- (2) Option and Restricted Stock were granted pursuant to the Company's equity incentive plan with no payment received for either.
