  - (3) The shares of restricted stock are subject to vesting as follows: (A) 105,263 shares vest in four equal installments on November 2, 2008, 2009, 2010 and 2011 (?Group A Shares?); (B) 74,184 shares vest in four equal installments on November 2, 2009, 2010, 2011 and 2012 (?Group B Shares?); and (C) 74,184 shares vest in four equal installments on November 2, 2010, 2011, 2012 and 2013 and, in each case, subject to GLG having achieved certain minimum levels of net assets under management (AUM) as of the immediately preceding October 31 (as determined by the Compensation Committee). On November 13, 2009, the second installment of 26,316 Group A Shares and the first installment of 18,546 Group B Shares vested with respect to 2009.
