- (1) On February 1, 2011, the trust established under the Urstadt Biddle Properties Inc. Excess Benefit and Deferred Compensation Plan of 2005 (the "Compensation Plan Trust") purchased 1,000 shares of Class A Common Stock at prices ranging between \$19.61 and \$19.69 per share for the benefit of Mr. Myers.
