 - (4) Total includes 2221.833 shares held in WD-40 Company Profit Sharing Plan (Company Stock Fund) account. Total also includes 8,179 Restricted Stock Units, of which 4,208 are subject to future vesting, 2,735 Market Share Units, all of which are subject to future vesting, and 1,734 PSUs, all of which are vested.
