- (1) On January 2, 2018, the Issuer entered into an agreement with Kevin J. Bannon (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 1,100 shares of Class A Common Stock that vests on January 2, 2023, pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) Of such shares, 5,200 are restricted shares, subject to vesting, issued pursuant to the Restricted Stock Award Plan, and 1,700 shares are held in the name of the Kevin J. Bannon IRA for the benefit of Kevin J. Bannon.
- (3) The Reporting Person is the indirect beneficial owner of 1,500 shares of Class A Common Stock, of which 500 shares are owned by the Katherine E. Bannon 2001 Revocable Trust dated 10/22/01, for the benefit of Katherine E. Bannon, Mr. Bannon's daughter, and 1,000 shares are owned by the Trust established under the will of Nathan B. Epstein for the benefit of Susan E. Bannon, Mr. Bannon's wife, et ano. Mr. Bannon is co-trustee of each of the above-mentioned trusts.
