Item 2.02 Results of Operations and Financial Condition.

On November 5, 2009, Deer Consumer Products, Inc. issued a press release:

- o announcing its financial results for the fiscal quarter ended September 30, 2009 where revenues increased 130% to \$26.54 million from \$11.54 million in the third quarter of 2008 and net income increased 168% to \$4.12 million from \$1.54 million in the third quarter of 2008;
- o affirms its 2009 earnings guidance of approximately \$10.5 million in net income on revenues of approximately \$81 million.
