Santiago, Chile. March 30, 2015.- Sociedad Química y Minera de Chile S.A. (SQM) (NYSE: SQM; Santiago Stock Exchange: SQM-B, SQM-A) informed that the President of the Company's Board of Directors provided the following information yesterday, in response to a request by the *Superintendencia de Valores y Seguros*, "SVS", (Superintendence of Securities and Insurance):

1. The Company has identified certain expenses associated with payments of fees and for advisory services that may not meet the requirements to be qualified as tax expenses under the Chilean tax code because of insufficient supporting documentation and because such expenses may not meet the requirement of being necessary to generate revenue. The expenses total approximately US\$11 million (an average of US\$1.8 million per year for 2009-2014), representing about 0.15% of the costs of goods sold of SQM S.A. for each of the six years of the period. The payments are associated with invoices issued by companies and persons with tax addresses in Chile.

The process of amending the corresponding annual statements began on March 20 of this year. SQM S.A. submitted today the final outstanding filings to the Chilean Internal Revenue Service (*Servicio de Impuestos Internos* or "SII")
2. for its analysis. The Company paid approximately US\$4 million related to expenses that do not qualify as tax expenses (35%) and approximately US\$3 million related to interest (1.5% monthly).

The amounts indicated above will be reflected in the Company's interim consolidated financial statements for the
3. first quarter of 2015 and will be charged to net income. The tax authority could also apply a penalty under the Chilean tax code. This potential penalty would be issued in the next few weeks.

The Company will send to the SII any supporting documents that it gathers in relation to the expenses and payments
4. described above, in order to request the tax refund for any tax payments that may have been paid in excess.

The SII is performing a tax review on SQM S.A. The Company has been and will continue to be reviewed by the
5. competent authorities, just like any other person or company in Chile. The Company cannot guarantee that such reviews will not lead to the identification of further situations that could result in further tax implications.

SQM is an integrated producer and distributor of specialty plant nutrients, iodine, lithium, potassium-related fertilizers and industrial chemicals. Its products are based on the development of high quality natural resources that allow the Company to be a leader in costs, supported by a specialized international network with sales in over 115 countries.
