This percentage was calculated by dividing (i) the number of shares of Common Stock reported in Item 4(a) held by the Reporting Person by (ii) 5,984,660, the number of shares of Common Stock issued and outstanding as of November 2, 2017, as reported in the Issuer's Form 10-Q filed on November 9, 2017 with the Securities and Exchange Commission (5,814,660) plus the additional shares outstanding if the stock option awards were exercised (170,000).

The Reporting Person has the power to vote and dispose of the 166,789 shares of Common Stock held directly as of December 31, 2017. In addition, the Reporting Person is eligible to acquire 170,000 additional shares via the exercise of vested stock option awards.
