(Comtech) dated April 30, 2004 (the Prospectus), relating to the potential resale from time to time of Comtech s 2.0% Convertible Senior Notes due 2024, the related guarantees of the notes by certain of Comtech s subsidiaries and the resale of Comtech s common stock issuable upon conversion of the notes. This prospectus supplement is not complete without, and may not be delivered or utilized except in connection with, the Prospectus, including any amendments or supplements thereto.

The conversion rate of 31.7460 is an adjusted rate of the initial conversion rate of 21.1640, which was adjusted to reflect the three-for-two stock split of Comtech's common stock, par value \$0.10, that occurred on April 4, 2005.
