There were 2,022,533 shares present in person or by proxy at the Annual Meeting, at which time the shareholders were asked to vote on one (1) proposal. Set forth below is the matter acted upon by the shareholders at the Annual Meeting, and the final voting results on such proposal.

### Proposal No. 1 - Election of Class B Directors

The shareholders voted to elect three (3) Class B directors to serve for a term of three (3) years and until their successors are elected and qualified. The results of the vote were as follows:
