- (2) The number of Indirect Securities Beneficially Owned in the BR Inc. Retirement Savings Plan (401 (k) Plan) is 1,931 shares which includes a increase of 65 shares between August 31, 2004 and December 31, 2004. This plan uses unit accounting to track fund balances.
- (3) The options vest in two equal annual installments beginning on January 26, 2006.
- (4) 1 for 1. These units vested under the BR 2001 Performance Share Unit Plan.
