**Remarks:**

Mr. Wesley earned a performance award equivalent to 60,000 shares of the issuer's common stock for the performance period Long-Term Incentive Plans. Payment of the performance award was approved on January 25, 2005. The issuer withheld 23,6 result of the award. Having significantly exceeded the Company's guidelines for executive stock ownership, Mr. Wesley elect (equivalent to the value of 36,330 shares) in cash. These transactions did not change Mr. Wesley's ownership of company stock to directly own 126,253 shares of the issuer's common stock and options to purchase 951,194 shares of common stock.
