 - (1) The reporting person was granted 10,000 Unit Appreciation Rights ("UARs") pursuant to a Unit Appreciation Rights Agreement (the "Agreement"), dated as of November 27, 2006, under the StoneMor Partners L.P. Long-Term Incentive Plan, between the reporting person and StoneMor GP LLC, the general partner of StoneMor Partners L.P. All of the UARs granted pursuant to the Agreement are performance vested UARs, which vest pursuant to a formula set forth in the Agreement. The exercise base price for each of the UARs is \$24.14.
 - (2) The UARs may be exercised only after vesting and to the extent vested. *See* Footnote 1.
 - (3) The UARs expire 5 years after the date of grant of November 27, 2006, provided that if the UARs have not fully vested at the end of such 5 year period, the 5 year period will automatically be extended for an additional 2 years.
 - (4) Upon exercise of the UARs, the reporting person will receive the number of whole common units determined by a formula set forth in the Agreement.
