(1) On January 22, 2010, 2,000 shares of restricted stock were issued to the Reporting Person by the Issuer. These shares vest on the earlier of: (1) one year from the date of grant; or (2) one day before the Issuer's 2011 Annual Meeting of Stockholders.

(2) The Reporting Person is a Managing Director of Crescendo Partners, a holder of 702,219 shares of the Issuer's outstanding common stock (the "Shares").
