- (1) As previously reported, on June 28, 2011, the reporting person received a restricted stock unit award for an aggregate of 78,337 shares. Up to 52,224 of these restricted stock units were eligible to vest upon achievement of certain performance metrics. On February 25, 2013, the compensation committee certified the performance metrics associated with the award. Based on actual performance, only 25,789 of the 52,224 performance-based restricted stock units are eligible to vest. The remaining 26,435 restricted stock units were cancelled.
