(1) In lieu of receiving cash fees, the reporting person received 403 stock units, which immediately vested, in the EnerSys Voluntary Deferred Compensation Plan for Non-Employee Directors (the 'Plan').
This amount reflects a matching stock unit contribution by EnerSys for the reporting person's account in the Plan. The matching stock unit contribution vests 25% on each of October 1, 2013, January 1, 2014, April 1, 2014, and July 1, 2014. Such vesting is subject to acceleration or cancellation upon the occurrence of certain events.
