  - (1) The reporting person was granted 25,000 Unit Appreciation Rights ("UARs") pursuant to a Unit Appreciation Rights Agreement (the "Agreement"), dated as of October 22, 2013, under the StoneMor Partners L.P. Long-Term Incentive Plan, as amended, between the reporting person and StoneMor GP LLC, the general partner of StoneMor Partners L.P. All of the UARs granted pursuant to the Agreement vest pursuant to a formula set forth in the Agreement.
  - (2) The UARs may be exercised only after vesting and to the extent vested. *See* Footnote 1.
  - (3) The UARs expire 5 years after the date of grant of October 22, 2013.
  - (4) Upon exercise of the UARs, the reporting person will receive the number of whole common units determined by a formula set forth in the Agreement.
