- (1) Each restricted stock unit represents a contingent right to receive one Ordinary Share of the Issuer.
- (2) The restricted stock units vest 100% on January 16, 2015. Vested shares will be delivered to the Reporting Person as soon as practicable (but no later than March 15, 2016). The restricted stock units may be settled in stock and/or cash payment.
The restricted stock units vest as follows: (i) 33.3% of the restricted stock units vest on January 16, 2014, (ii) 33.3% of the restricted stock units vest on February 2, 2015, and (iii) 33.4% of the restricted stock units vest on February 2, 2016. Vested shares will be delivered to the Reporting Person upon the earlier to occur of (x) February 2, 2018 and (y) the date of a Change in Control. The restricted stock units may be settled in stock and/or cash payment.
- (3) The restricted stock units vest as follows: (i) 66.6% of the restricted stock units vest on January 16, 2014, and (ii) 33.4% of the restricted stock units vest on February 1, 2015. Vested shares will be delivered to the Reporting Person upon the earlier to occur of (x) June 18, 2017 and (y) the date of a Change in Control. The restricted stock units may be settled in stock and/or cash payment.
