#### Item 9. Regulation FD Disclosure

On October 15, 2003, Parker-Hannifin Corporation (Parker) presented a Webcast announcing earnings for the quarter ended September 30, 2003. Attached as Exhibit 99.1 to this report are revised versions of several Webcast slides clarifying certain verbal disclosures made by Parker during the Webcast regarding segment operating margins and realignment charges incurred during the quarters ended September 30, 2003 and 2002. The above-mentioned slides reconcile segment operating margins reported in accordance with U.S. GAAP to segment operating margins adjusted to remove the effect of realignment charges incurred during the respective quarters. These charges are removed to allow investors and Parker to meaningfully evaluate operating margins on a comparable basis from period to period.
