QVT Financial LP ( QVT Financial ) is the investment manager for QVT Fund LP (the Fund ), which beneficially owns 71,760 Shares, QVT Overseas Ltd., which beneficially owns 258,176 Shares, and for QVT Associates LP, which beneficially owns 57,316 Shares. QVT Financial is also the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account ), which holds 100,748 Shares. QVT Financial has the power to direct the vote and disposition of the Shares held by each of the Fund, QVT Overseas Ltd., QVT Associates LP and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 488,000 Shares, consisting of the Shares owned by the Fund, QVT Overseas Ltd., QVT Associates LP and the Shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of Shares reported by QVT Financial.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the Shares owned by the Fund, QVT Overseas Ltd. and QVT Associates LP and the Shares held in the Separate Account.
