On March 14, 2008, MidWestOne Financial Group, Inc., formerly known as ISB Financial Corp. (the Company), completed a merger with the former MidWestOne Financial Group, Inc. (Former MidWestOne). The Company was the surviving corporation in the merger. Pursuant to Rule 12g-3(a) of the Securities Exchange Act of 1934, the Company is deemed to be the successor issuer to Former MidWestOne and, pursuant to Rule 12g-3(g), the Company is required to file an annual report for Former MidWestOne covering the last full fiscal year of Former MidWestOne prior to the Company's succession. Because the merger was not consummated until March 14, 2008, the Company did not have sufficient time to complete and file Former MidWestOne's annual report on or prior to March 31, 2008. Accordingly, the Company will delay the filing of Former MidWestOne's Form 10-K for the year ended December 31, 2007.
