**Item 4. Ownership.**

(a) Amount beneficially owned:

QVT Financial LP ( QVT Financial ) is the investment manager for QVT Fund LP (the Fund ), which beneficially owns 673,489 shares of Common Stock, and for Quintessence Fund L.P. ( Quintessence ), which beneficially owns 72,418 shares of Common Stock. QVT Financial is also the investment manager for a separate discretionary account managed for a third party (the Separate Account ), which holds 71,565 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by the Fund, Quintessence and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 817,472 shares of Common Stock, consisting of the shares owned by the Fund and Quintessence and the shares held in the Separate Account.

The Fund, Quintessence and the Separate Account own warrants to purchase additional shares of Common Stock that are not exercisable until the later of the Issuer s completion of a business combination and October 2, 2008, and will expire on October 2, 2011 or earlier upon redemption. As of the date of this filing, there has been no report of the completion of a business combination.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Fund and Quintessence, may be deemed to beneficially own the aggregate number of shares of Common Stock owned by the Fund and Quintessence, and accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 745,907 shares of Common Stock.

Each of QVT Financial and QVT Financial GP LLC disclaims beneficial ownership of the shares of Common Stock owned by the Fund, Quintessence and the Separate Account. QVT Associates GP LLC disclaims beneficial ownership of all shares of Common Stock owned by the Fund and Quintessence, except to the extent of its pecuniary interest therein.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated based upon 10,845,300 shares of Common Stock outstanding, which is the total number of shares issued and outstanding reported in the Issuer s Quarterly Report on Form 10-Q for the quarter ended September 30, 2008 and filed with the Securities and Exchange Commission on November 14, 2008.
