As at 9.00am on 2<sup>nd</sup> March 2010 Prudential's issued share capital consists of 2,532,269,795 ordinary shares of 5p each and which are admitted to trading. Each ordinary share carries the right to one vote in relation to all circumstances at general meetings of Prudential. Prudential does not hold any ordinary shares in Treasury.

Therefore, the total number of voting rights in Prudential is 2,532,269,795.
