This Amendment No. 4 (this Amendment ) is being filed by Frank Stronach ( Mr. Stronach ), the Stronach Trust, 445327 Ontario Limited ( 445 ) and 446 Holdings Inc. ( 446 ; 446, together with Mr. Stronach, the Stronach Trust and 445, the Reporting Persons ) and amends the Statement on Schedule 13D filed on October 1, 2007, as previously amended, by the Reporting Persons (the Statement ). This Amendment is being filed to report various dispositions of Common Shares by the Reporting Persons.

*Item 4. Purpose of the Transactions.*

(a) The Reporting Persons completed open market sales of 2,449,670 Common Shares between December 7 and December 16, 2010 in order to take advantage of market conditions and opportunities for sale at prices which the Reporting Persons considered favorable. Additionally the Reporting Persons donated 29,600 Common Shares to the University of Florida on December 9, 2010. The Reporting Persons intend to dispose of an indeterminate number of additional Common Shares from when market conditions are deemed favorable. However, the Reporting Persons will continue to evaluate their ownership and voting position in the Issuer and may consider and pursue other future courses of action, including among others, the possibility of continuing to hold a substantial number of the Reporting Persons or their representatives may engage in communications with other shareholders of the Issuer and members of the Issuer's management and board of directors with regard to the business operations of the Issuer and strategies for enhancing shareholder value.

(a) The Reporting Persons completed open market sales of 2,449,670 Common Shares between December 7 and December 16, 2010 in order to take advantage of market conditions and opportunities for sale at prices which the Reporting Persons considered favorable. Additionally the Reporting Persons donated 29,600 Common Shares to the University of Florida on December 9, 2010. The Reporting Persons intend to dispose of an indeterminate number of additional Common Shares when market conditions are deemed favorable. However, the Reporting Persons will continue to evaluate their ownership and voting position in the Issuer and may consider and pursue other future courses of action, including among others, the possibility of continuing to hold a substantial number of Common Shares for investment. The Reporting Persons or their representatives may engage in communications with other shareholders of the Issuer and members of the Issuer's management and board of directors with regard to the business operations of the Issuer and strategies for enhancing shareholder value.

Other than as described above and elsewhere in this Statement, none of the Reporting Persons currently has plans or proposals that relate to or would result in any of the consequences listed in paragraphs (a) through (j) of Item 4 of the Special Instructions for Complying with Schedule 13D.

*Item 5. Interest in Securities of the Issuer.*

(a) The aggregate number of common shares outstanding as of December 8, 2010 was 242,662,912 based upon the information provided by Computershare Trust Company of Canada, the Company's transfer agent. As of the date hereof, 446 holds 15,520,730 Common Shares of the Company, which shares may also be deemed to be beneficially owned by Mr. Stronach, the Stronach Trust and 445. In addition, Mr. Stronach holds options to purchase 2,700,000 Common Shares, of which 183,332 are vested and exercisable within 60 days from the date hereof.

(c) 446 donated 29,600 Common Shares to the University of Florida on December 9, 2010 and also sold Common Shares in the open market during the past sixty days as set forth below:
