On August 15, 2011, Casey's General Stores, Inc. (the Company) reported July 2011 same-store sales results for stores open for one full year. Same-store sales for prepared food and fountain increased 13.5%, and grocery and other merchandise increased 7.3% in July 2011 compared to July 2010.

Same-store gasoline gallons sold decreased 2.8% in July 2011 compared to July 2010. The gasoline margin was above the Company's fiscal 2012 goal of 13.5 cents per gallon. The average retail price of gasoline sold during July 2011 was \$3.54 per gallon.
