Item 7.01. Regulation FD Disclosure.

On February 15, 2012, Casey's General Stores, Inc. (the Company) reported January 2012 same-store sales results for stores open for one full year. Same-store sales for prepared food and fountain increased 16.8%, and grocery and other merchandise increased 6.3% in January 2012 compared to January 2011.

Same-store gasoline gallons sold decreased 1.7% in January 2012 compared to January 2011. The gasoline margin was in line with the Company's fiscal 2012 goal of 13.5 cents per gallon. The average retail price of gasoline sold during January 2012 was \$3.17 per gallon.
