## FIDUS INVESTMENT CORPORATION ANNOUNCES

### COMMENCEMENT OF PUBLIC OFFERING OF COMMON STOCK

**EVANSTON, Ill., September 6, 2012** Fidus Investment Corporation (NASDAQ:FDUS) ( Fidus or the Company ) today announced the commencement of a registered public offering of its shares of common stock through an underwritten public offering. The Company also plans to grant the underwriters a 30-day option to purchase an additional number of shares of its common stock at the public offering price to cover over-allotments, if any.

The Company intends to invest the net proceeds of this public offering in lower middle market companies in accordance with its investment objective and strategies, and for working capital and general corporate purposes. Raymond James & Associates, Inc. and Robert W. Baird & Co. Incorporated are joint bookrunning managers for the offering. BB&T Capital Markets, a division of Scott & Stringfellow, LLC, and Oppenheimer & Co. Inc. are co-lead managers for the offering.

**This issuance of shares will be made pursuant to a shelf registration statement on Form N-2 that has been filed with, and has been declared effective by, the U.S. Securities and Exchange Commission. The offering may be made only by means of a prospectus and a related prospectus supplement, copies of which may be obtained, when available, from Raymond James, 880 Carillon Parkway, St. Petersburg, Florida 33716. Investors are advised to carefully consider the investment objectives, risks and charges and expenses of the Company before investing. The preliminary prospectus supplement and accompanying prospectus contain this and other information about the Company and should be read carefully before investing.**

Fidus is an externally managed, closed-end, non-diversified management investment company that has elected to be treated as a business development company under the Investment Company Act of 1940, as amended. In addition, for tax purposes, Fidus has elected to be treated as a regulated investment company, or RIC, under Subchapter M of the Internal Revenue Code of 1986, as amended, or the Code. Fidus was formed in February 2011 to continue and expand the business of Fidus Mezzanine Capital, L.P., which commenced operations in May 2007 and is licensed by the US Small Business Administration as a small business investment company.
