Item 1. Security and Issuer.

The name of the issuer is New Peoples Bankshares, Inc., a Virginia bank holding company headquartered in Honaker, Virginia (the Issuer). The address of the Issuer's principal executive offices is 67 Commerce Drive, Honaker, Virginia 24260. This Schedule 13D relates to the Issuer's common stock, par value \$2 per share.

Item 2. Identity and Background.

(c) Mr. White is self-employed as a cattle rancher in Castlewood, Virginia and is also a private investor.

(d) During the last five years, Mr. White, has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

(e) During the last five years, Mr. White, has not been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Item 3. Source or Amount of Funds or Other Consideration.

On December 28, 2012, 1,475,933 shares of the Issuer's common stock were issued to Mr. White as a result of his investment in the rights offering of common stock of New Peoples Bankshares that closed on December 20, 2012. Mr. White through indirect purchases in the rights offering acquired 161,000 additional shares of common stock. Mr. White was awarded an additional 295,186 warrants to purchase common stock. Through indirect purchases of related parties, an additional 20,216 warrants were awarded. Total shares of common stock after the completion of the stock offering is 3,757,834 shares directly owned and 161,000 indirectly owned. Total warrants to purchase common stock directly owned are 687,163 and indirectly 20,216. Total stock options to purchase common stock were 8,060 options.

Item 4. Purpose of Transaction.

Mr. White and his indirect related parties participated in the common stock rights offering of the Company to increase his investment in the organization.

Item 5. Interest in Securities of the Issuer.

- (a) As of the date hereof, Mr. White beneficially owns 4,634,273 shares of the Issuer's common stock, which represents approximately 20.52% of the outstanding shares of the class. Of this amount 707,379 shares represent Common Stock Warrants issued to Mr. White as a result of the conversion of the loan into the Issuer's common stock in September 2012 and participation in the common stock rights offering that closed on December 20, 2012. 8,060 shares represent stock options issued to Mr. White.

- (b) Mr. White has sole voting and dispositive power with regard to 4,453,057 shares of the Issuer's common stock. Mr. White has shared voting and dispositive power with regard to 181,216 shares of the Issuer's common stock.

Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer.

Mr. White is a member of the Board of Directors of the Issuer. From time to time Mr. White may have banking transactions with the Issuer's banking subsidiary New Peoples Bank, Inc.
