(e) On December 5, 2013, at our annual meeting of stockholders, our stockholders approved an amendment to our 2010 Employee, Director and Consultant Equity Incentive Plan, as amended (the 2010 Plan), to set the number of shares of common stock available for grant of awards under the 2010 Plan to an aggregate of 3,500,000 shares. (a) On December 5, 2013, we held our 2013 Annual Meeting of Stockholders (the Annual Meeting). Of the 76,334,892 shares of common stock outstanding as of the record date of October 8, 2013, a quorum of 67,089,852 shares, or approximately 87.9 % of the eligible shares, was present in person or represented by proxy.
