Accordingly, the shares reported herein by CWAM include those shares separately reported herein by Columbia Acorn Select.

CWAM disclaims beneficial ownership of any shares reported herein.

Item 6. Ownership of More than Five Percent on Behalf of Another Person:

To the knowledge of CWAM and Columbia Acorn Select, no other persons besides CWAM and Columbia Acorn Select and those persons for whose shares of common stock CWAM reports beneficial ownership have the right to receive or the power to direct the receipt of dividends from or the proceeds from the sale of the securities of the issuer reported herein. As of December 31, 2013, only Columbia Acorn Select, a Massachusetts business trust managed by CWAM, owned more than 5% of the class of securities reported herein.

Any remaining shares reported herein by CWAM are held by various other funds or accounts managed by CWAM which each have the right to receive any dividends paid by the issuer and could terminate their respective investment advisory relationship with CWAM and then subsequently direct the use of proceeds from the sale of common stock owned by such fund or account. To CWAM's knowledge, none of these other funds or accounts owned more than 5% of the outstanding shares of the issuer as of December 31, 2013.
