**Item 1. Security and Issuer.**

This Amendment No. 1 to Schedule 13D (the *Amendment*) is being filed as an amendment to the original statement on Schedule 13D relating to the Common Stock, \$0.001 par value per share (*Common Stock*) of Regulus Therapeutics Inc., a Delaware corporation (the *Issuer*) as filed with the Securities and Exchange Commission (the *SEC*) on October 19, 2012 (the *Original Schedule 13D*). This Amendment is being filed by the Reporting Persons to report (i) the sale between June 25, 2014 and October 24, 2014 of an aggregate of 253,784 shares of the Issuer's Common stock by Isis pursuant to a Rule 10b5-1 trading plan adopted on May 22, 2014 and (ii) the sale on November 3, 2014 of 1,279,411 shares of the Issuer's Common Stock by Isis to the underwriters in connection with a registered public offering pursuant to the Issuer's Registration Statement on Form S-3 (No. 333-194293).

Items 4, 5 and 7 and Schedule A of the Original Schedule 13D are hereby amended and supplemented to the extent hereinafter expressly set forth and, except as amended and supplemented hereby, the Original Schedule 13D remains in full force and effect. All capitalized terms used in this Amendment but not defined herein shall have the meanings ascribed thereto in the Original Schedule 13D.

**Item 4. Purpose of Transaction.**

*Item 4 of the Original Schedule 13D is hereby amended and supplemented by adding the following paragraph at the end of Item 4:*

Between June 25, 2014 and October 24, 2014, Isis sold an aggregate of 253,784 shares of the Issuer's Common Stock pursuant to a Rule 10b5-1 trading plan adopted on May 22, 2014. On November 3, 2014, Isis sold 1,279,411 shares of the Issuer's Common Stock in connection with a registered public offering pursuant to the Issuer's Registration Statement on Form S-3 (No. 333-194293).

**Item 5. Interest in Securities of the Issuer.**

*Item 5 of the Original Schedule 13D is hereby amended and restated in its entirety as follows:*

The following information with respect to the ownership of the Common Stock of the Issuer by the Reporting Persons filing this Schedule 13D is provided as of November 3, 2014:

- (a) The Reporting Persons beneficially own 5,541,305 shares of the Common Stock of the Issuer, or approximately 11.4% of the Issuer's outstanding Common Stock.
- (b) Isis has sole power to vote and dispose of the securities of the Issuer held by it. Crooke and Parshall may be deemed to beneficially own the securities of the Issuer held by Isis and have shared voting and dispositive powers over the securities. Crooke and Parshall disclaim beneficial ownership of the securities except to the extent of their pecuniary interest therein.
- (c) The Reporting Persons have not effected any other transactions in the Issuer's Common Stock within the past sixty days, except as provided herein.
