**Item 3.03 Material Modification to Rights of Security Holders**

On August 3, 2015, The Charles Schwab Corporation (the Company) issued and sold 24,000,000 depository shares ( Depository Shares ), each representing a 1/40th ownership interest in a share of 6.00% non-cumulative perpetual preferred stock, Series C, \$0.01 par value, with a liquidation preference of \$1,000 per share (equivalent to \$25 per Depository Share) (the Series C Preferred Stock ). The Company filed a Certificate of Designations (the Certificate of Designations ) with the Secretary of State of the State of Delaware, establishing the voting rights, powers, preferences and privileges, and the relative, participating, optional or other rights, and the qualifications, limitations or restrictions thereof, of the Series C Preferred Stock on July 30, 2015. Holders of the Depository Shares will be entitled to all proportional rights and preferences of the Series C Preferred Stock (including dividend, voting, redemption and liquidation rights).

Under the terms of the Series C Preferred Stock, the ability of the Company to pay dividends on, make distributions with respect to, or to repurchase, redeem or acquire its common stock or any preferred stock ranking on parity with or junior to the Series C Preferred Stock, is subject to restrictions in the event that the Company does not declare and either pay or set aside a sum sufficient for payment of dividends on the Series C Preferred Stock for the immediately preceding dividend period.

The terms of the Series C Preferred Stock are more fully described in the Certificate of Designations which is included as Exhibit 3.1 to this Current Report on Form 8 K and is incorporated by reference herein.

**Item 5.03 Amendments to Articles of Incorporation or Bylaws; Change in Fiscal Year**

The Certificate of Designations became effective upon filing with the Secretary of State of the State of Delaware. The terms of the Series C Preferred Stock are more fully described in the Certificate of Designations which is included as Exhibit 3.1 to this Current Report on Form 8 K and is incorporated by reference herein.

**Item 8.01 Other Events**

On July 27, 2015, the Company entered into an Underwriting Agreement (the Underwriting Agreement ) with Merrill Lynch, Pierce, Fenner & Smith Incorporated, Morgan Stanley & Co. LLC, UBS Securities LLC and Wells Fargo Securities, LLC, as the representatives of the several underwriters named therein (collectively, Underwriters ), under which the Company agreed to sell to the Underwriters 24,000,000 shares of Depository Shares, each representing a 1/40th ownership interest in a share of Series C Preferred Stock.

The Underwriting Agreement contains customary representations, warranties and agreements of the Company, conditions to closing, indemnification rights and obligations of the parties, and termination provisions. Under the terms of the Underwriting Agreement, the Company agreed to indemnify the Underwriters against certain specified types of liabilities, including liabilities under the Securities Act of 1933, as amended, and to contribute to payments the Underwriters may be required to make in respect of these liabilities.

The net proceeds of the offering of the 24,000,000 Depository Shares were approximately \$581 million, after deducting underwriting discounts and commissions and estimated offering expenses. The offering was made pursuant to the prospectus supplement dated July 27, 2015 and the accompanying prospectus dated December 15, 2014, filed with the Securities and Exchange Commission pursuant to the Company s effective registration statement on Form S-3 (File No. 333-200939) (the Registration Statement ). The following documents are being filed with this Current Report on Form 8-K and are incorporated by reference into the Registration Statement: (a) the Underwriting Agreement, (b) the

Certificate of Designations to which the Form of Certificate Representing the Series C Preferred Stock is attached as Exhibit A, (c) the Deposit Agreement dated August 3, 2015, between the Company and Wells Fargo Bank, N.A., as Depositary, to which the Form of Depositary Share Receipt is attached as Exhibit A and (d) a validity opinion with respect to the Depositary Shares and the Series C Preferred Stock.
