**EXPLANATORY NOTE**

**DEREGISTRATION OF SECURITIES**

This Post-Effective Amendment relates to the Registration Statement initially filed on Form S-1 (Commission File No. 333- 204906) by Shell Midstream Partners, L.P., a Delaware limited partnership (the Partnership ), with the Securities and Exchange Commission (the SEC ) on June 12, 2015, registering 7,692,308 common units representing limited partner interests of the Partnership for resale, from time to time, by the selling unitholders named therein (as amended, the Registration Statement ). The Registration Statement was declared effective by the SEC on July 23, 2015. Post-Effective Amendment No. 2 to the Registration Statement, which the Partnership filed with the SEC on January 8, 2016, converted the Form S-1 into a registration statement on Form S-3, which was declared effective by the SEC on January 27, 2016.

The Partnership has no further obligation to maintain effectiveness of the Registration Statement. In accordance with an undertaking made by the Partnership in the Registration Statement to remove from registration by means of a post-effective amendment any registered securities which remain unsold at the termination of the offering, this Post-Effective Amendment No. 1 is being filed to terminate the effectiveness of the Registration Statement and to remove from registration all securities registered but not sold under the Registration Statement. As a result of this deregistration, no securities remain registered for resale pursuant to the Registration Statement.
